4. Font & Spacing Criteria:
  - Font Type (body of the document) - Times New Roman
  - Font size (body of the document) – 12 pt.
  - Line spacing option - 1.5
  - Font Type (Footnote) - Times New Roman
  - Font size (Footnote) – 10 pt.
  - Margin spacing - 1 inch on all sides of each page.
5. The pages should be numbered appropriately.
6. The Projects submitted should compulsorily contain the following contents:

- Cover Page
- Acknowledgement
- Table of Contents
- Introduction
- Body of your Project
- Bibliography
- Statutes
- Books
- Articles
- Case Laws

7. The Cover Page of the project must contain the following details:

- Title
- Subject
- Student name
- Roll number & Division
- College Name

8. Students are encouraged to be creative with respect to their submissions.

9. Students may refer to books, research articles, case laws, etc., for writing the projects.

10. Hard copy of Project with spiral binding should be submitted to the college office on or before **20<sup>th</sup> September, 2025**.
